Should the ball fail either to act or to indicate the exact time, it will be rehoisted if necessary, and lowered slowly at 0h. 5m. P.M. The signal will be made on every day except Sundays and legal or national holidays.

The light-boat, exhibiting a white fixed light moored about one mile to the westward of St. Andrew's Point, will be replaced by the Berbice Light-vessel, exhibiting a white fixed light, which will be moved about 9 miles S. 34° W. from her present position (N. 34° E. 10 miles from St. Audrew's Point) for that purpose, the light-boat being permanently withdrawn.

Approximate position, light-vessel when moved, lat. 6° 22′ N., long. 57° 28′ W.

The spit extending from Crab Island will be marked by a beacon or a light-buoy. [Variation 1° Westerly in 1902.]
