I hereby give notice, pursuant to the 9th section of the Act 5 and 6 Victoria, cap. 110, intituled "An Act for better preserving the navigation of the River Mersey," that I have received a notice from Mr. William Cooper, given pursuant to the provisions of the above-mentioned Act, of his intention to construct a river wall at West Bank, Widnes, in accordance with plans and sections deposited at this Office, a copy of which notice is subjoined.

In pursuance of an Act for better preserving the navigation of the River Mersey (5 and 6 Vic., cap. 110), I, William Cooper, Terrace-road, West Bank, Widnes, Flat Owner and Sail Maker, hereby give notice that I propose to construct at my Shipyard and Sailworks, West Bank, Widnes, in accordance with plans and sections deposited at the office of the Mersey Conservancy, a retaining wall for the support of my works.

The wall is to be 75 feet long on the eastern side of above works facing the River Mersey, and returned on the southern side 82 feet in line with Irwell-street, in the borough of Widnes, Lancashire. The wall is to support my workshops and is to be on the same line and in lieu of the existing structure.

The wall is to be constructed of red sandstone facing with cement concrete backing and will be commenced at an early date and will not project beyond the line of the existing structure, nor forther impede nor interrupt the tidal or other waters of the River Mersey. The foundation of the wall is to be about 10 feet above Ordnance Datum.
