

ORDER OF THE BOARD OF  
AGRICULTURE.

(DATED 13TH OCTOBER 1902.)

(SWINE-FEVER INFECTED AREA.)

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

*Revocation of Order.*

1. The Order described in the Schedule to this Order is hereby from and after the commencement of this Order revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Swine-Fever (Infected

Areas) Order of 1896 and the Order described in the Schedule to this Order before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, those Orders before the commencement of this Order.

*Commencement.*

2. This Order shall come into operation on the seventeenth day of October, one thousand nine hundred and two.

No. 716.—BRITISH COLUMBIA—QUEEN  
CHARLOTTE SOUND.*Sealed Passage and North Channel—Rocks  
Reported.*

Information, dated 15th September, 1902, has been received from Commander C. H. Simpson, His Majesty's surveying-vessel "Egeria," of the existence of the undermentioned rocks in Queen Charlotte Sound:—

1. A rock, with less than 6 feet of water over it, and marked by kelp, situated in Sealed Passage with eastern extreme of Reid Island bearing S. 81° E., distant 6 cables, and Middle Rock N. 38° E.

Approximate position, lat. 51° 0 $\frac{3}{4}$ ' N., long. 127° 41 $\frac{3}{4}$ ' W.

2. A rock, which occasionally breaks, but over which the depth has not yet been determined, situated in North Channel, with the south-eastern islet of the Southgate Group bearing N. 15° W., distant 3 $\frac{3}{4}$  cables, and the summit of Annie Rock N. 75° E.

Approximate position, lat. 50° 58 $\frac{3}{4}$ ' N., long. 127° 33' W.

3. A rock, with 2 $\frac{1}{2}$  fathoms of water over it, situated in North Channel, with the south-eastern islet of the Southgate Group bearing N. 31° W., distant 2 $\frac{1}{4}$  cables, and the summit of Annie Rock N. 85° E.

Approximate position, lat. 50° 59' N., long. 127° 32 $\frac{1}{2}$ ' W.
