' 1° Les voyageurs venant de Constantinople par Bourgas et Varna, par bateau, et Hebibtchevo, par chemin de fer, ne seront admis en Bulgarie qu'après avoir subi une visite médicale rigoureuse et après une désinfection de leurs bagages et effets. Dans ce but, les voyageurs s'arrêteront au lazaret de la quarantaine pendant une ou plusieurs journées jusqu'à ce que la désinfection et la visite médicale soient terminées;

2° Les trains, y compris "l'Orient Express," devront s'arrêter à la quarantaine d'Hebibtchevo afin de laisser les voyageurs qui resteront en Bulgarie, ainsi que leurs bagages;

3° Pour les bateaux venant de Constantinople ne seront ouverts que les ports de Bourgas et Varna où il leur sera donné libre pratique après une visite médicale rigoureuse;

4° L'arrêté No. 246 du 27 Juin a.c. est rapporté, excepté les mesures énumérées au § 4 de cet arrêté; et

5° Les objets vieux et ayant servi venant de Constantinople, qui sont accompagnés de certificat constatant qu'ils sont des objets de ménage, seront admis après une désinfection.
