INSTRUMENT substituting the New Church of | Saint John the Baptist, situate within the New Parish of Loxwood, in the County of Sussex, and in the Diocese of Chichester, for the Old Church of Saint John the Baptist, situate within and hitherto being the Parish Church of the same new parish.

To all to whom these presents shall come, the Ecclesiastical Commissioners for England send greeting:

WHEREAS a new church has lately been built within the new parish of Loxwood, in the county of Sussex, and in the diocese of Chichester, and has been consecrated and dedicated to Saint John the Baptist.

And whereas the Right Reverend Ernest Roland Bishop of the said diocese of Chichester, as such Bishop, the Reverend William Mainprice, Clerk in Holy Orders, the Vicar or Incumbent of the vicarage of the parish of Wisborough Green, in the said county and diocese, as the patron of the vicarage of the said new parish of Loxwood, and the Reverend Clonard Hatton Hildebrand, Clerk in Holy Orders, as the Vicar or Incumbent of the last-named vicarage, have, by an instrument under their hands, bearing date on or about the eleventh day of March, in the year one thousand nine hundred and two, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said new parish of Loxwood, that the said new church of Saint John the Baptist, situate within such new parish, should be substituted for the old parish church (also dedicated to Saint John the Baptist) of the same new parish.

Now therefore, we, the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do by this instrument, under our common seal, with the consent (testified as hereinafter mentioned) of the said Ernest Roland, Bishop of the said diocese of Chichester, and of the said William Mainprice and Clonard Hatton Hildebrand, hereby declare that the said new Church of Saint John the Baptist, situate within the said new parish of Loxwood and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church (dedicated to Saint John the Baptist as aforesaid), of the same new parish and that such new church shall henceforth be the parish church of the said new parish of Loxwood, in lieu of the said old parish church of Saint John the Baptist as fully in all respects as if the said new church of Saint John the Baptist so hereby substituted, had been originally the parish church of the same new parish. And we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments and rights of or belonging to the said old parish church (dedicated to Saint John the Baptist as aforesaid) of the said new parish of Loxwood, or of or belonging to the Vicar or Incumbent thereof, to the said new church of Saint John the Baptist (now being by virtue of these presents the parish church of the 4, Whitehall Place, London, S.W.

said new parish of Loxwood), and to the Vicar or Incumbent thereof, and his successors, for ever.

In witness whereof to these presents, we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said Ernest Roland Bishop of the said diocese of Chichester has set his hand and affixed his episcopal seal, and the said William Mainprice and Clonard Hatton Hildebrand have respectively set their hands and affixed their seals this twenty-fourth day of April, in the year one thousand nine hundred and

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 3RD NOVEMBER 1902.)

(Swine-Fever Infected Area.)

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, lo order, and it is hereby ordered, as follows:

Declaration of Swine-Fever Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be an area infected with swine fever for the purposes of the Swine-Fever (Infected Areas) Order of 1902.

Commencement.

2. This Order shall come into operation on the eighth day of November, one thousand nine hundred and two.
