

to say in the new parish of Saint Peter Woolton otherwise Much Woolton, in the new parish of Saint Nicholas Halewood, in the new parish of the Holy Trinity Wavertree, and in the new parish of Saint Stephen Gateacre.

"Now therefore with the consent of the said Peter Sorenson Royston (in testimony whereof he has signed and sealed this scheme) and with the consent of the said Francis James Bishop of the said diocese of Liverpool (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal) we, the said Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to each of the said benefices of Saint Peter Woolton, otherwise Much Woolton, Saint Nicholas Halewood, Holy Trinity Wavertree, and Saint Stephen Gateacre, now vested in him the said Peter Sorenson Royston as such vicar or incumbent of the said vicarage of Childwall shall be transferred from him the said Peter Sorenson Royston and from his successors vicars or incumbents of the said vicarage of Childwall to the said Francis James Bishop of the said diocese of Liverpool and his successors Bishops of the same diocese and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Francis James Bishop of the said diocese of Liverpool and by his successors Bishops of the same diocese for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Liverpool. *A. WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the sixth and seventh years of Her late Majesty Queen Victoria chapter thirty-seven duly prepared and laid before His Majesty in Council a scheme bearing date the thirteenth day of November, in the year one thousand nine hundred and two, in the words following, that is to say;

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the sixth and seventh years of Her late Majesty Queen Victoria chapter thirty-seven, have prepared and now humbly lay before Your Majesty in Council the following scheme for authorizing

the sale and disposal of certain property situate in the parish of Paddington in the county of Middlesex.

"Whereas under and by virtue of an indenture bearing date the twelfth day of January one thousand eight hundred and eighty-two and made or expressed to be made between John Aldridge of Inholmes in the county of Berks Esquire of the one part and us the Ecclesiastical Commissioners for England of the other part the hereditaments described in the schedule hereto annexed became with their appurtenances and are now vested in us in fee simple for the purposes and subject to the provisions applicable to other hereditaments vested in us.

"And whereas the hereditaments aforesaid are not subject to any outstanding beneficial lease or grant but are now in our possession but some portions thereof on account of their character or situation are unsuitable or inconvenient to be held or applied for the purposes for which estates vested in us are applicable under the Acts by which our proceedings are governed.

"And whereas with a view to the advantageous appropriation of the same or of the proceeds thereof for the ultimate improvement of our common fund it is expedient that the said hereditaments or such part or parts thereof as we shall at any time and from time to time think fit should be sold or disposed of and accordingly that we should be empowered to sell or dispose of our interest in such hereditaments or in any part or parts thereof in such manner as shall appear to us advisable.

"Now therefore we humbly recommend and propose that we may be authorized and empowered by instrument or instruments in writing duly executed according to law from time to time to sell or dispose of and duly to convey according to the provisions of the said Acts all or any of the said hereditaments so vested in us as aforesaid with their appurtenances and all our estate right title and interest therein or in any part or parts thereof unto and to the use of any person or persons desirous or willing to purchase the same and his or their heirs executors administrators or assigns or otherwise as he or they shall direct or appoint and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable it being our intention to invest the proceeds of such sale from time to time as occasion may arise in the purchase of other lands tithes rent charges tenements or hereditaments or of some estate or interest therein convenient to be held by us for the purposes of the Acts by which our proceedings are governed as aforesaid and in the meantime to invest the said proceeds in some Government or Parliamentary Stock or other public securities in England.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Act or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"All that piece or parcel of land situate at Westbourne Green in the parish of Paddington in the county of Middlesex being part of a field formerly called Mitcham Hills and containing in quantity one acre two roods and thirty-three perches or thereabouts and shewn by the green colour on the plan annexed to the indenture referred to in the foregoing scheme."
