A Bridge over the Grand Surrey Canal with roadways and approaches thereto wholly in the Parish and Metropoliton Borough of Camberwell commencing in Saint George'sroad Peckham at a point therein 3½ chains or thereabouts measured in a westerly direction from Castlemain-road and terminating in Neate-street at a point therein opposite the southern end of Albany-row.

To authorize the Camberwell Conneil to cross and interfere with the said Grand Surrey Canal and to cross open or break up divert raise lower alter stop up or interfere with either temporarily or permanently streets roads highways footpaths towpaths watercourses drains culverts sewers gas and water mains and pipes -telegraphic electric and other wires pipes and apparatus and to execute such other Works as may be mecessary for the purposes of and incidental to the said intended Bridge Approaches and Works and to authorize deviations laterally and vertically from the lines and levels of the said bridge as shown upon the Plans and Sections hereinafter mentioned to any extent which may be defined in the Bill.

Street Widening by the Council of the Royal Borough of Kensington.

To empower the Council of the Royal Borough of Kensington (in this Notice referred to as "the Kensington Council") to execute the following street widening in the Parish of Saint Mary Abbotts Kensington (that is to say):

Á widening of High-street Notting Hill on the southern side thereof between points respectively $1\frac{1}{2}$ chains or thereabouts measured in a westerly direction from the Mall and 1 chain or thereabouts measured in an easterly direction from Silver-street.

To empower the Kensington Council to stop up and appropriate the site and soil of any passage or place within the limits of deviation shown on the deposited Plans of the said street widening hereinafter referred to.

To make provision with respect to the laying out and maintenance and repair of the widened portion of the said street.

To empower the Kensington Council to deviate laterally and vertically from the lines and levels of the said street widening as shown on the Plans and Sections hereinafter mentioned to any extent which may be defined by the Bill.

To empower the Kensington Council for the purposes of and in connection with the said widening to alter and interfere with sewers drains steps areas cellars cellar-flaps gratings fencings windows water-courses pipes and spouts.

To make special provisions with respect to the compensation payable by the Kensington Council for the acquisition of insanitary property.

To empower the Kensington Council to raise rsink or otherwise alter the position of watercourses water pipes and gas pipes belonging to or connected with houses and buildings and mains pipes or apparatus laid down or used by any Company or person for carrying a supply of water or water for hydraulic power or gas and pipes tubes wires and apparatus laid down or placed for telegraphic and other purposes and for supplying electricity.

To empower the Kensington Council to enter into and carry into effect agreements with owners of property with respect to the sale and exchange of lands and other property.

To enable the Council to contribute towards the cost of the said street widening.

To provide for the exercise by the Council subject to the provisions of the intended Act of all or any of the beforementioned powers and in that event to empower and require the Kensington Council to contribute towards the cost thereby incurred by the Council.

To enable the Council and the Kensington Council to enter into and carry into effect agreements with respect to all or any of the matters aforesaid.

General and Incidental Powers.

To enable the Council the Cambcrwell Council and the Kensington Council respectively to purchase by compulsion or agreement all such lands houses and other property as may be required by them respectively for the purposes of the Bill or as may be delineated upon the deposited Plans hereinafter referred to as intended to be taken and any easements over or affecting the same and to appropriate such lands for the purposes aforesaid.

To incorporate and apply to the purposes of the intended Act with modifications and variations the provisions or some of the provisions of "The Railways Clauses Consolidation Act 1845" and of "The Railways Clauses Act 1863" and of the Lands Clauses Acts and to enable the Council the Camberwell Council and the Kensington Council respectively to purchase so much only of any property as may be required for the purposes of the intended Act and to exempt the said Councils from the liability imposed by the 92ud section of "The Lands Clauses Consolidation Act 1845" and from the provisions of the said Act with respect to the sale of superfluous lands and to exempt the Council from the operation of Section 133 of "The Lands Clauses Consolidation Act 1845."

To make provision as to the payment of costs in certain cases of disputed compensation by persons claiming compensation from the said Councils.

To make any special provisions as to determining the purchase money and compensation payable in respect of lands and property required for the purposes of the intended Act and to provide for limiting the amount thereof and claims in respect thereof in cases of recent buildings and alterations and recently created interests therein.

To enable the said Councils respectively and their officers to enter to survey and value at any time lands and buildings shown on the deposited Plans and to obtain information as to their value and ownership.

To enable the said Councils respectively to sell convey lease exchange and otherwise dispose of for building purposes or otherwise any lands houses and property or any easement right or privilege in under through or over the same which may be acquired by or vested in them under the powers and may not be required for the purposes of the Bill and to sell and dispose of any building paving or other materials.

To enable the said Councils respectively in selling or disposing of lands acquired by them for the purposes of the intended Act but not actually required for such purposes to attach conditions as to the use thereof and to enable the said Councils respectively to enforce such conditions by power of re-entry penalties or otherwise.

Extension of Time.

To extend the time limited by "The London County Council (General Powers) Act 1898" for the widening of York-road in the Parishes
