ORDER of the Local Government Board : Alteration of General Consolidated Order: Duties and Fees of Workhouse Medical Officer.

PARISH OF WILLESDEN.

To the Guardians of the Poor of the Parish of Willesden :-

And to all others whom it may concern.

Whereas by a General Order of the Poor Law Commissioners bearing date the eighth day of December, one thousand eight hundred and forty-seven (hereinafter referred to as "the Order"), which is in force in the parish of Willesden, certain rules and regulations were made relating to the administration of relief to the Poor:

And whereas by Article 181 of the Order provision is made for the payment of special fees to the Medical Officer of the Workhouse of the said parish in certain cases, and by Article 206 of the Order the duties to be performed by the said Medical Officer are prescribed;

And whereas it is expedient that the operation of Article 181 of the Order should be suspended as hereinafter mentioned as regards the Medical Officer of the Acton Lane Workhouse of the said parish, and that further provision should be made with regard to the duties of the said Medical Officer:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order with respect to the Medical Officer for the time being for the Acton Lane Workhouse of the said parish us follows :-

ARTICLE J. The operation of Article 181 of the Order shall be and is hereby suspended until We,

by Order, shall otherwise direct. ARTICLE II. The following words shall be added to the paragraph numbered No. 2 in Article 206 of the Order; namely,-

And in like manner, with the consent of any officer or assistant appointed or employed at the Workhouse, to attend upon and supply medicines to such officer or assistant, when so directed by the Guardians or by the Visiting Committee.

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 4TH DECEMBER 1902.)

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf. do order, and it is hereby ordered, as follows :

1.-(1.) Notwithstanding the provisions of the Foreign Animals (Amendment) Order of 1902 (No. 2), animals now being brought in the Vessel described in the Schedule hereto from any of the States in the United States of America mentioned in such Order may be landed at the Liverpool (Birkenhead) Foreign Animals Wharf in accordance with the provisions of this Order and not otherwise.

(2.) The animals may be landed with the permission of an Inspector of the Board, which permission will only be given where the Inspector is satisfied that sufficient lairage and other accommodation is-available for the landing and slaughter of the animals in accordance with the provisions of this Article. (3.) The animals shall only be landed at such

part of the Wharf as an Inspector of the Board may direct, and when landed shall be driven by lairage-men to such lairs within the limits of the Wharf as may be specially approved for that purpose by an Inspector of the Board.

(4.) After such examination as may be required by an Inspector of the Board, the animals shall either be immediately slaughtered in the lairs in which they then are, or they may, with the per-mission of an Inspector of the Board, be forthwith moved to a slaughter-house specially approved for that purpose by an Inspector of the Board and there immediately slaughtered.

2. This Order shall be read as part of the Foreign Animals Order of 1896 and Article 31 (Offences) of that Order shall pply to offences against this Order.
