TAKE notice, that this Honourable Court will be moved on the 16th day of December, 1902, at 12 o'clock at noon, on behalf of the above named Maple and Co., of Tottenham Court-road, in the county of London, who are secured creditors of the above named bankrupt, Albert Nash, against Cecil Mercer, of 95, Temple-chambers, London, the Official Receiver of the estate of the said Albert Nash, for:—1. For an Order that the Respondent Official Receiver do pay to the said Maple and Co. the said sum of £156 6s. 11d., or such other sum as the Court may direct, due to the said Maple and Co. by virtue of the charge aforesaid. And 3. For an Order on the Respondent Official Receiver to pay to the applicants out of the estate of the said bankrupt their costs of and incident to this application.
