ARTICLE I .- It shall be the duty of District Auditor to audit the Accounts of the following Authorities and their Officers;

namely,—
(1.) The Guardians of the Poor of the several
Poor Law Unions named in the Schedule to

(2.) The Overseers of the Poor of the several Parishes comprised in the said several

(3.) The several other Authorities for the time being whose accounts are or may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within one or more of the said Unions, and whose Accounts are not subject to audit by any other District Auditor.

(4.) The Board of Management of the Walsall and West Bromwich District School.

(5.) The School Boards for the United School District of Inkberrow and the United School District of Willenhall and Bentley.

(6.) The Joint Committee appointed to exercise the powers and duties of a Burial Board by the Parish Councils of the parishes of Halesowen, Hasbury, Hawn, Lapal, Lutley, and The Hill, and the Parish Meetings of the Parishes of Illy and Hunnington.

(7.) Such other Authorities whose Accounts are or may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being partly situated within one or more of the said Unions, as We may by

Order hereafter prescribe.

ARTICLE II.—The District Auditor shall audit the said Accounts according to the provisions of the several Statutes and of the Orders issued by competent authority in force for the time being in that behalf, and shall perform all such duties and exercise all such powers in connection with the audit of such Accounts as are prescribed and conferred by the said Statutes and Orders.

ARTICLE III.—The District in which the District Auditor shall act as Auditor, and which We hereby assign to him for the performance of his duties under this Order, shall be termed "The Warwickshire Audit District," and shall, until We otherwise prescribe, comprise the several Poor Law Unions named in the Schedule to this Order, the District of the Board of Management named in Paragraph (4) of Article I of this Order, the United School Districts named in Paragraph (5) of the said Article, the area subject to the jurisdiction of the Joint Committee referred to in Paragraph (6) of the said Article, and the Districts or areas subject to the jurisdiction of any such Authority as is mentioned in Paragraph (7) of the said Article.

ARTICLE IV.—Any Order in force assigning a District to the District Auditor for the discharge of his duties or prescribing his duties, and any Order in force assigning the Warwickshire Audit District to any other District Auditor, shall, from and after the date upon which this Order shall come into operation, be rescinded, but nothing in this Order shall affect or interfere with the existing duties and powers of any District Auditor as regards any Audit or any matters or proceedings already commenced.

ARTICLE V .- In this Order-

The term "Overseers of the Poor" includes Churchwardens and Assistant Overseers.

ARTICLE VI.—This Order shall come into operation on the first day of January, one thousand nine hundred and three, provided that,
