Barito River Entrance-Alteration in Beucons.

The Netherlands Government has given notice, dated 5th January, 1903, that the following alterations have been made in the beacons at the entrance to the Barito River :---

1. The wooden beacon, Lange Jan, situated 3 miles to the westward of Burung Point, has been replaced by a screw pile beacon, painted white with one red horizontal band, and surmounted by a conical topmark.

2. The old beacon, situated $2\frac{1}{2}$ miles to the southward of Burung Point, has been replaced by a screw pile beacon painted red with one white horizontal band, and surmounted by a conical topmark.

The above beacons are intended for hydrographic purposes only.

Culebra Harbour-Shoal Marked by Buoy.

The United States Government has given notice, dated 20th December, 1902, of the existence of a pinnacle rock or coral head, with a depth of 13 feet over it, in the western approach to Culebra Harbour; it is situated with Parrot Point bearing N. 43° W., distant 7 cables, and southern extremity of Soldier Point S. 52° W.

A buoy marked No. $2\frac{1}{2}$ has been placed in a depth of $7\frac{1}{2}$ fathoms 10 feet to the westward of its position.
