sanction the appointment of joint committees of the contracting parties to carry into effect any agreements entered into under the provisions of the intended Act.

20. To enable the Company notwithstanding anything contained in the Companies Clauses Consolidation Act 1845 to pay out of the capital or any funds of the Company from time to time interest or dividends on any shares stocks or debenture stock of the Company at such rate as the intended Bill may prescribe.

21. To vary and extinguish all rights and privileges which would or might interfere with any of the objects of the Bill and to confer other

rights and privileges.

22. To incorporate with the Bill and to extend to the Company and to the railways proposed to be constructed under the powers of the intended Bill all or any of the provisions of the Companies Clauses Consolidation Act 1845 the Companies Clauses Acts 1863 and 1869 the Lands Clauses Acts the Railways Clauses Consolidation Act 1845 and the Railways Clauses Act 1863 with such alteration variations and amendments as may be deemed expedient.

23. To alter amend and extend and if need be to repeal the provisions or some of the provisions of the several Acts of Parliament follow-

ing (that is to say):—

24.
