

The KING's Most Excellent Majesty in Council. HEREAS, by the Burial Act, 1855, it was amongst other things enacted that it should be lawful for His Majesty, by and with the advice of His Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials there-under, or other operation of such Order, should or should not have arrived), as to His Majesty, with such advice as aforesaid, might seem fit:

And whereas an Order in Council was made on the eighth February, one thousand eight hundred and fifty-five, directing the discontinuance of burials in certain places within the city of Canterbury, from the time specified in such Order:

And whereas the said Order in Council of e eighth February, one thousand eight hundred and fifty-five, was varied by an Order in Council of the twenty-sixth February, one thousand eight hundred and ninety-seven, and the said Orders in Council of the eighth February, one thousand eight hundred and fifty-five, and twenty-sixth February, one thousand eight hundred and ninety-seven, were varied by an Order in Council of sixteenth February, one thousand nine hundred and three, so far as they affected burials in Canterbury Cathedral:

And whereas it seems fit to His Majesty, by and with the advice of His Privy Council, that the said Orders in Council be further varied:
