LIGHT RAILWAYS ACT, 1896.

London United Tramways (Light Railway Extensions) Order.

The Light Railway Commissioners have submitted to the Board of Trade, for confirmation under the above-mentioned Act, an Order made by them for the construction of Light Railways in the County of Middlesex between Hounslow and Cranford and between Heston, Hounslow, Hanworth, Twickenham, and Sunbury Cross, being extensions of the existing and authorized Undertaking of the London United Tramways (1901) Limited.

Appointed Day.

Order made under Section 27 (2) of the Education Act, 1902.

Whereas by Sub-section (2) of Section 27 of the Education Act, 1902 (hereinafter referred to as "the Act"), it is enacted that the Act shall, except as expressly provided, come into operation on the appointed day, and the appointed day shall be the twenty-sixth day of March, nineteen hundred and three, or such other day, not being more than eighteen months later, as the Board of Education may appoint, and different days may be appointed for different purposes and for different provisions of the Act and for different Councils.

And whereas by an Order dated the sixteenth day of March, nineteen hundred and three, the Board of Education have fixed the first day of April, uineteen hundred and three, as the appointed day for the purposes of Sub-section (5) of Section 23 of the Act.

And whereas by an Order dated the twenty-fourth day of March, nineteen hundred and three, the Board of Education have fixed as the appointed day for the Council of the county borough of Newcastle-on-Tyne for the purposes and provisions of Part II of the Act, and of so much of the Act as is consequential upon and necessary for the operation of Part II of the Act the first day of May, nineteen hundred and three, or such later day or days as the Board might for any such purpose or provision for the said Council thereafter appoint, and as the appointed day for the said Council for all other purposes and provisions of the Act, except for the purposes of Sub-section (5) of Section 23 aforesaid, the thirtieth day of September, nineteen hundred and

three, or such later day or days as the Board might for any such purpose or provision for the said Council thereafter appoint.

Now, therefore, the Board of Education, pursuant to the Act and every other power enabling them in that behalf, hereby appoint as the appointed day for the Council of the said county borough of Newcastle-on-Tyne for all purposes and provisions of the Act, except for the purposes of Sub-section (5) of Section 23, the thirtieth day of September aforesaid, or such later day or days as the Board may for any such purpose or provision for the said Council thereafter appoint.
