**WILD BIRD (ENGLAND).**

The Wild Birds Protection (County of the Parts of Lindsey, Lincolnshire) Order, 1903.

Dated 27th August, 1903.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1902, and upon application by the County Council of the Administrative County of the Parts of Lindsey, Lincolnshire, I hereby make the following Order:—

*Title.*

I. This Order may be cited as "The Wild Birds Protection (County of the Parts of Lindsey, Lincolnshire) Order, 1903."

**BIRDS.**

*Close Time varied.*

II. The time during which the killing or taking of Wild Birds is prohibited by the Act of 1880 shall be varied within the Administrative County of the Parts of Lindsey, Lincolnshire, so as to be between the last day of February and the 16th day of August in any year.

*Additions to the Schedule of the Act of 1880.*

III. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of the Parts of Lindsey, Lincolnshire, to the following species of Wild Birds, in the same manner as if those species were included in the schedule to the Act:—

Common Buzzard, Honey Buzzard, Hobby, Kestrel, House Martin, Sand Martin, Merlin, Swallow, Swift, Wryneck.

*Certain Birds protected during the whole of the Year.*

IV. During the period between the 15th day of August in any year and the 1st day of March following, the killing or taking of the following species of Wild Birds is prohibited throughout the Administrative County of the Parts of Lindsey, Lincolnshire:—Goldfinch, Great Crested Grebe, Kingfisher, House Martin, Sand Martin, Nightingale, Owl (all species), Oyster Catcher, Ruff or Reeve, Swallow, Tern, Wagtail (all species), Woodpecker (all species).

**EGGS.**

*Certain Eggs protected throughout the County.*

V. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the Administrative County of the Parts of Lindsey, Lincolnshire:—

Common Buzzard, Honey Buzzard, Cuckoo, Wild Duck (all species), Goldfinch, Hobby, Kestrel, Kingfisher, House Martin, Sand Martin, Merlin, Nightingale, Nightjar, Owl (all species), Ruff or Reeve, Snipe, Swallow, Swift, Teal, Wagtail (all species), Woodcock, Woodpecker (all species), Wryneck.

*Other Eggs protected within a certain Area.*

VI. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the undermentioned area within the Administrative County of the Parts of Lindsey, Lincolnshire, namely; the sea coast, sandhills, dunes, waste lands, fitties, foreshore, and warrens situate between the sea and the land side of the sea wall, embankment, ditch, quick fence, or other artificial boundary separating the same from the cultivated land:—

Ringed Dotterel, Oyster Catcher, Redshank, Common Sandpiper, Sheldrake, Arctic Tern, Common and Lesser Tern.

*Repeal of former Order.*

VII. The Order of the 18th May, 1900, is hereby repealed.

**BOARD OF EDUCATION.**

*Appointed Day.*

Order made under Section 27 (2) of the Education Act, 1902.

Whereas by Sub-section (2) of Section 27 of the Education Act, 1902 (hereinafter referred to as "the Act"), it is enacted that the Act shall, except as expressly provided, come into operation on the appointed day, and the appointed day shall be the twenty-sixth day of March, nineteen hundred and three, or such other day, not being more than eighteen months later, as the Board of Education may appoint, and different days may be appointed for different purposes and for different provisions of the Act and for different Councils.

And whereas by an Order dated the sixteenth day of March, nineteen hundred and three, the Board of Education have fixed the first day of April, nineteen hundred and three, as the appointed day for the purposes of Sub-section (5) of Section 23 of the Act.

And whereas by Orders dated the twenty-ninth day of May and the thirty-first day of July, nineteen hundred and three, the Board of Education have fixed as the appointed day for the Councils of the Boroughs of Harwich and Rawtenstall for all other purposes and provisions of the Act the first day of September, nineteen hundred and three, or such later day or days as the Board might for any such other purpose or provision for either of the said Councils thereafter appoint.

Now, therefore, the Board of Education, pursuant to the Act and to every other power enabling them in that behalf, hereby appoint as the appointed day for each of the said Councils, for all such other purposes and provisions, the thirtieth day of September, nineteen hundred and three, or such later day or days as the Board may for any such other purpose or provision for either of the said Councils hereafter appoint.
