14. Passengers arriving on board vessels without a clean bill of health, and the Officers of such vessels, will be permitted to land after medical inspection, but will not be permitted to land any of their luggage or effects until the same shall have been thoroughly disinfected. This clause does not apply to deck passengers.

15. Passengers arriving from infected places, after 10 days from date of departure will be admitted to free pratique after strict medical inspection and thorough disinfection of their persons, effects, and luggage, if the inspecting Medical Officer is satisfied that they are in good health; but, in the case of vessels carrying a doctor, disinfection of the person will not be required.

16. Passengers not otherwise provided for are subjected to the restrictions applicable to

the vessels on which they arrive.

17. When 20 days have elapsed from the last case of plague, cholera, or other disease against which restrictions have been in force with regard to a country or place declared to be an infected place, a notice will be issued by the Collector of Customs to the effect that the place or port is no longer to be dealt with as infected.

N B. - Vessels passing through the Suez Canal without taking on board either cargo or passengers, will not be considered infected by contact with Canal Pilots taken on board from a disinfection station or by coaling and provisioning at Suez or Port Said, provided that the quarantine restrictions at those ports are considered satisfactory by the Chief Government Medical Officer.

The word "passengers," as used in this notice, except in clause 14, includes the officers and crew of vessels.
