C Hardy, His Majesty's surveying vessel "Waterwitch," that an examination recently made of the area north-east of Tung Yung Island shows there is nothing less than depths of 29 fathoms, mud, in the position, or in the neighbourhood of the rock reported to exist 6 miles north-eastward from that island; this rock, the existence of which rests on slender foundation, and of which nothing is known by the Chinese fishermen in the neighbourhood, has therefore been expunged from the Charts.
