eighteen chains or thereabouts to the point where such lane meets the boundary which divides the said new parish of Christ Church North End Finchley from the said new parish of Saint Paul Long-lane Finchley."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation.

And whereas a period of two calendar months has elapsed since the said drafts were transmitted to the said patrons and Incumbents and such patrons and Incumbents have made no objections to such scheme or representation.

And whereas the said scheme or representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the thirtieth day of July, in the year one thousand nine hundred and three, in the words following, that is to say:—

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint Alban Upton Park situate in the new parish (sometime consolidated chapelry) of Saint Stephen Upton Park in the county of Essex, and in the diocese of Saint Albans.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saiut Alban Upton Park situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Edgar Bishop of the said diocese of Saint Albaus (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said new parish of Saint Stephen Upton Park which is described in the Schedule hereunder written, all which part,

together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Alban Upton Park situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Alban Upton Park.' And with the like consent of the said Edgar Bishop of the said diocese of Saint Albans (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Alban Upton Park situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being. Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing

Representation has reference. "The District Chapelry of Saint Alban Upton Park being :—

"All that part of the new parish (sometime consolidated chapelry) of Saint Stephen Upton Park in the county of Essex and in the diocese of Saint Albans which is bounded upon the south-west by the new parish of Saint Andrew Plaistow upon the south-east and upon the northeast by the parish of East Ham both in the said county and diocese and upon the remaining sides that is to say upon the north-west and upon the west by an imaginary line commencing upon the boundary which divides the said parish of East Ham from the said new parish of Saint Stephen Upton Park at the centre of the bridge which carries Katherine-road over the line of the London Tilbury and Southend Railway and extending thence south-westward along the middle of the said line of railway for a distance of twenty-one chains or thereabouts to a point opposite to the middle of Priory-road and extending thence south-eastward to and along the the middle of Priory-road for a distance of twenty-seven chains or thereabouts to its junction with Castle-street and extending thence south-westward along the middle of Castlestreet for a distance of ten chains or thereabouts to its junction with Green-street upon the boundary which divides the said new parish of Saint Stephen Upton Park from the said new parish of Saint Andrew Plaistow."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Saint Albans.
