And whereas an Order in Council was made on the twenty-third day of November, one thousand eight hundred and ninety three, directing the discontinuance of burials, with certain exceptions, in amongst other places the parish churchyard of Easington, in the county of Durham:

And whereas it seems fit to His Majesty, by and with the advice of His Privy Council, that so much of the said Order as relates to Easington be varied:

Now, therefore, His Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that so much of the said Order of the twenty-third day of November, one thousand eight hundred and ninety-three, as relates to the parish of Easington, be varied by the addition of the following clause to the article in the said Order relating to burials in the parish churchyard of Easington, viz. :--

(d.) In the churchyard in the space which has been reserved and appropriated as a burial place for the family of Robert Colvin Spark the burial may be allowed, at or below the depth of five feet from the surface of the ground, of the bodies of the said Robert Colvin Spark and his wife at their decease.
