Notice is hereby given, that in pursuance of the provisions of the twenty-first section of an Act passed in the thirty-eighth year of the reign of Her late Majesty, intituled "The Births and Deaths Registration Act, 1874," I, William Cospatrick Dunbar, C.B., Registrar-General of Births, Deaths, and Marriages in England, have, with the sanction of the Local Government Board, ordered and declared that, on and after the first day of November next, in order that Loddon Registration District may consist of two Sub-Districts respectively co-extensive with the two Relief Districts of Loddon and Clavering Poor Law Union, Woodton Sub-District of Loddon Registration District shall be dissolved and its constituent Civil Parishes dealt with in the following manner, viz.:—(a) Bedingham, Hedenham, Kirstead, Mundham, Seething, Topcroft, and Woodton Civil Parishes shall be transferred to Loddon Sub-District of the same Registration District; and (b) Broome, Ditchingham, and Thwaite Civil Parishes shall be added to Aldeby Sub-District of the same Registration District.—Witness my hand this 24th day of October, one thousand nine hundred and three.
