## ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(Dated 25th November 1903.)

(SWINE-FEVER INFECTED AREA.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Revocation of Orders.

1. The Orders described in the Schedule to this Order are hereby from and after the commencement of this Order revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Swine-Fever (Infected

Areas) Order of 1902, and the Orders described in the Schedule to this Order before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, those Orders before the commencement of this Order.

## Commencement

2. This Order shall come into operation on the thirtieth day of November, nineteen hundred and three.
