Rules of the Supreme Court The following draft Rules are published pursuant to the Rules Publication Act, 1893:-Order LIX.—Rules 19 and 20.

1. The following Rules shall be added to

Order LIX: 19. An appeal from any decision of the Central Midwives Board under the Midwives Act, 1902 shall be made to the Divisional Court of the High Court of Justice by notice of motion and supported by affidavit, or, if the Court shall so direct on the hearing of the motion, by oral

evidence. 20. The notice of motion shall be an eight days notice, and shall be filed at the Crown Office, and upon filing the notice the appeal shall be set down in the Crown paper for hearing as if it were an appeal from an Inferior Court.

Order XXII.—Rule 17.

2. Order XXII, Rule 17, shall have effect as if the following paragraph were thereto:-

Debenture, Preference, Guaranteed or Rent Charge, Stocks of Railways in Great Britain or Ireland guaranteed by Railway Companies owning Railways in Great Britain or Ireland which have for ten years next before the date of investment paid a dividend on Ordinary Stock or Shares.

Appendix N.—No. 106.
3. Appendix N, item 106, shall be read as if one shilling and three pence were specified therein in lieu of one shilling.

4. These Rules shall come into operation on the 15th of January, 1904.
