To all to whom these presents shall come the Ecclesiastical Commissioners for England send greeting.

WHEREAS a new church has lately been built at Shaldon, within the parish of Saint Nicholas, in the county of Devon, and in the diocese of Exeter, and has been consecrated and dedicated to Saint Peter.

And whereas the Right Reverend Herbert Edward, now Bishop of Winchester, but at that time Bishop of Exeter, as diocesan, the Honourable Hugh Fortescue, commonly called Viscount Ebrington, as the patron of the vicarage of the said parish of Saint Nicholas, and the Reverend Richard Marsh Marsh-Dunn, Clerk in Holy Orders, as the vicar or Incumbent of the said vicarage, have by an Instrument under their hands bearing date on or about the thirtieth day of July, in the year one thousand nine hundred and two, certified to us the said Ecclesiastical Commissioners for England that it would be for the convenience of the said parish of Saint Peter, situate within such parish, should be substituted for the old parish church (dedicated to Saint Nicholas) of the same parish.

Now, therefore, we the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do by this Instrument, under our common seal, with the consent (testified as hereinafter mentioned) of the Right Reverend Archibald, now Bishop of Exeter, and of the said Hugh Viscount Ebrington, and of the said Richard Marsh Marsh-Dunn, hereby declare that the said new church of Saint Peter, situate within the said parish of Saint Nicholas, and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church (dedicated to Saint Nicholas as aforesaid) of the same parish, and that such new church shall henceforth be the parish church of the said parish of Saint Nicholas, in lieu of the said old parish church of the said parish, as fully in all respects as if the said new church of Saint Peter so hereby substituted, had been originally the parish church of the same parish. said Ecclesiastical Commissioners England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church (dedicated to Saint Nicholas as aforesaid) of the said parish of Saint Nicholas, or of or belonging to the vicar or Incumbent thereof, to the said new church of Saint Peter (now being by virtue of these presents the parish church of the said parish of Saint Nicholas), and to the vicar or Incumbent thereof and his successors for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners

for England, have set our common seal, the said Archibald, Bishop of Exeter, has set his hand and affixed his episcopal seal, and the said Hugh Viscount Ebrington and Richard Marsh Marsh Dunn have respectively set their hands and affixed their seals this seventeenth day of December, in the year one thousand nine hundred and three.
