

Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of All Saints Norwood, of the new parish of Saint Paul Thornton Heath, and of the new parish of Saint John the Evangelist Upper Norwood, all in the county of Surrey, and in the diocese of Canterbury

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the eighth day of August in the year one thousand eight hundred and forty-five and published in the London Gazette on the twelfth day of the same month a chapelry district was assigned to the consecrated church of All Saints situate at Norwood in the parish of Croydon in the said county and diocese and such chapelry district was named 'The Chapelry District of All Saints Norwood.'

"And whereas the said chapelry district of All Saints Norwood has under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four become a new parish of the character contemplated by that Act by the Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the nineteenth day of August in the year one thousand eight hundred and seventy-one and published in the London Gazette on the twenty-second day of the same month certain portions of the said new parish of All Saints Norwood and of the district chapelry of Saint Saviour Croydon in the said county and diocese were constituted a separate district for spiritual purposes, and such district was named 'The District of Saint Paul Thornton Heath.'

"And whereas the said district of Saint Paul Thornton Heath has become a new parish of the character contemplated by the above-mentioned Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the twenty-sixth day of October in the year one thousand eight hundred and seventy-five and published in the London Gazette on the twenty-ninth day of the same month certain portions of the said new parish of All Saints Norwood, of the new parish of Saint Mark South Norwood in the said county and diocese and of the said new parish of Saint Paul Thornton Heath were constituted a separate district for spiritual purposes and such district was named 'The District of Saint John the Evangelist Upper Norwood.'

"And whereas the said district of Saint John the Evangelist Upper Norwood has become a new parish of the character contemplated by the above-mentioned Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven, and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas it has been represented to us, and it appears to us to be expedient that the boundaries of the said new parish of All Saints Norwood the said new parish of Saint Paul Thornton Heath and the said new parish of Saint John the Evangelist Upper Norwood should be altered in the manner which is hereinafter mentioned.

"Now therefore with the consent of the Right Honourable and Most Reverend Randall Thomas

Archbishop of Canterbury (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of All Saints Norwood the said new parish of Saint Paul Thornton Heath and the said new parish of Saint John the Evangelist Upper Norwood shall be altered so that (firstly) all that portion of the said new parish of All Saints Norwood which is described in the first schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said new parish of Saint Paul Thornton Heath and (secondly) all that portion of the said new parish of Saint Paul Thornton Heath which is described in the second schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured green shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said new parish of All Saints Norwood and (thirdly) all that portion of the said new parish of Saint Paul Thornton Heath which is described in the third schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured violet shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said new parish of Saint John the Evangelist Upper Norwood.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or any of them or any other Act of Parliament.

"The SCHEDULES to which the foregoing Scheme or Representation has reference.

"THE FIRST SCHEDULE.

"The territory to be dissevered from the new parish of All Saints Norwood in the county of Surrey and in the diocese of Canterbury and to be annexed to the new parish of Saint Paul Thornton Heath in the same county and diocese being:—

"All that portion of the said new parish of All Saints Norwood which is bounded upon the south-west and upon the south-east by the new parish of Saint Paul Thornton Heath aforesaid and upon the remaining sides that is to say upon the north-east and upon the north-west by an imaginary line commencing upon the boundary which divides the said new parish of Saint Paul Thornton Heath from the new parish of All Saints Norwood aforesaid at the junction of Spa-road with Ingram-road and extending thence north-westward along the middle of the last-named road for a distance of twenty-eight chains and a half or thereabouts to its junction with Downs-view-road and with Virginia-road and extending thence first westward and then south-westward along the middle of the last-named road for a distance of thirty chains or thereabouts to its junction with Green-lane upon the boundary which divides the said new parish of All Saints Norwood from the new parish of Saint Paul Thornton Heath aforesaid.
