Manchester which under the fourth section of the Parish of Manchester Division Act 1850 constitutes for all ecclesiastical purposes the parish of Manchester, namely:—All that portion of such ecclesiastical parish of Manchester which is bounded upon the east by the parish of Saint Thomas Redbank, upon the north-east, upon the north-west and upon the west by the parish (sometime district under the Parish of Manchester Division Act 1850) of Saint Alban Cheetwood upon the south-west by the parish of Trinity Salford all in the said county and diocese and upon the remaining side, that is to say, upon the south-east, by an imaginary line commencing upon the boundary which divides the said parish of Trinity Salford from the said ecclesiastical parish of Manchester at the centre of the bridge which carries the line of the Lancashire and Yorkshire Railway across the River Irwell and extending thence north-castward along the middle of the said line of railway (thereby passing through Victoria Railway Station) for a distance of seventeen chains and a half or thereabouts to the centre of the bridge which carries Corporation-street across such line of railway upon the boundary which divides the said ecclesiastical parish of Manchester from the said parish of Saint Thomas Redbank.

"II. And also all that portion of the said parish of Saint Alban Cheetwood which is bounded upon the south-west by the parish of Saint Simon Salford in the said county and diocese, upon the south-east partly by the said ecclesiastical parish of Manchester partly by the said parish of Saint Thomas Redbank and partly by the parish of Saint Luke Cheetham Hill in the said county and diocese, upon the north-east by the parish of Saint John the Evangelist Cheetham in the said county and diocese, and upon the remaining side, that is to say, upon the northwest by an imaginary line commencing upon the boundary which divides the said parish of Saint John the Evangelist Cheetham from the said parish of Saint Alban Cheetwood at the junction of Elizabeth-street with the northern portion of Sherbourne-screet, and extending thence southwestward along the middle of the northern portion of Sherbourne-street for a distance of of eleven chains or thereabouts to its junction with Allison-street, and extending thence southwestward and in a straight line for a distance of nine chains or thereabouts to the junction of Broughton-street with the southern portion of Sherbourne-street and extending thence south-westward along the middle of the southern portion of Sherbourne-street for a distance of thirty-five chains or thereabouts to the centre of the bridge which carries such street across the River Irwell upon the boundary which divides the said parish of Saint Alban Cheetwood from the said parish of Saint Simon Salford."

And whereas drafts of the said scheme have, in accordance with the provisions of the firstly hereinbefore mentioned Act, been transmitted to the patrons and to the Incumbents of the cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patrons and Incumbents have respectively signified their assent to such scheme.

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and

His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

The KING's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four; of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation, bearing date the eleventh day of February, in the year one thousand nine hundred and four, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four of the Act of the thirteenth and fourteenth years of Her said late Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the parish (being a new parish) of Saint Mark Regent's Park, and of the parish (being a new parish) of Saint Michael Camden Town both within the original limits of the parish of Saint Pancras in the county of Middlesex and in the diocese of London.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the thirteenth day of June in the year one thousand eight hundred and fifty-three and published in the London Gazette on the twenty-eighth day of the same month a certain part of the said parish of Saint Pancras was assigned as a district chapelry to the consecrated church of Saint Mark situate in Albert-road, Regent's Park, in the said parish of Saint Pancras, and the said district chapelry was named 'The District Chapelry of Saint Mark, Saint Pancras.'

"And whereas the said district chapelry of Saint Mark Saint Pancras has under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four and under the provisions of the Saint Pancras Ecclesiastical Regulation Act 1868 become a new parish of the character contemplated by the said Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four by the Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas the said church of Saint Mark situate in Albert-road, Regent's Park, has under the provisions of the said Saint Pancras Ecclesiastical Regulation Act, 1868, taken the name of 'The Church of Saint Mark, Regent's Park' and the said district chapelry of Saint Mark, Saint Pancras, has taken the name of 'The Parish of Saint Mark, Regent's Park,' and is hereinafter called by that title.
