MOTOR CAR ACT, 1903.

Front Leading Light. The French Government has given notice, dated 1st March, 1904, that the front leading light at Port Guilvinec (Guilfinec) will shortly be altered to show red from the bearing of N. 5° W., through north, to N. 23° E., and white (as before) from N. 23° E., through east, to S. 78° E., but obscured in other directions; the red light will be visible in clear weather from a distance of 5 miles, its light power being 28 candles. In other respects the light will remain as before.
