SURREY (SWINE-FEVER INFECTED PLACES) ORDER OF 1904.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

## Application of Order.

1. This Order applies only to Swine-Fever Infected Places in the administrative county of Surrey (including the borough of Godalming, but excluding the boroughs of Guildford, Kingston-upon-Thames, Reigate, and Richmond).

#### Removal of Carcases from Infected Places.

2. Notwithstanding anything contained in the Swine-Fever Order of 1894 or in any Regulation made thereunder it shall be lawful for any person to remove from a Swine-Fever Infected Place to which this Order applies, any carcase of a pig which is intended to be used for the food of man and has been scalded for that purpose, provided that it is not the carcase of a pig that at the time of its death was affected with or suspected of swine-fever or of a pig slaughtered under the Diseases of Animals Act, 1894: Provided that any person who removes a carcase under this Article shall forthwith notify to the Local Authority of the county of Surrey the fact of such removal, the place to which the carcase is removed, and the name and address of any person to whom it is consigned.

### Commencement.

3. This Order shall come into operation on the eighth day of April, nineteen hundred and four.
