Moss-street is crossed by the Bolton Blackburn and Hellifield Line of the Lancashire and Yorkshire Railway and extending thence south-westward along the middle of the said line of railway for a distance of eleven chains or thereabouts to the centre of the bridge which carries such line of railway across Stanley-street and extending thence north-eastward along the middle of Stanley-street for a distance of four chains and a half or thereabouts to its junction with Appleby-street and extending thence southwestward along the middle of Appleby-street for a distance of half a chain or thereabouts to a point opposite to the middle of the wall forming the boundary between the premises known as Plantation Mill and the premises known as Appleby's Corn Mill otherwise Daisyfield Corn Mills and extending thence south-eastward to and along the said boundary wall for a distance of four chains or thereabouts to its south-eastern end on the north-western side of the towing path of the Leeds and Liverpool Canal and continuing thence south-eastward in the same direction and in a straight line for a distance of twelve yards or thereabouts to a point in the middle of the said canal upon the boundary which divides the said new parish of Saint Michael and All Angels Blackburn from the said new parish of Saint Thomas Blackburn.'

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and Incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

The KING's Most Excellent Majesty in Council. W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her late Majesty Queen Victoria, chapter thirty-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, duly prepared and laid before His Majesty in Council a scheme bearing date the twenty-fourth day of March, in the year one thousand nine hundred and four, in the words and figures following, that is to say :-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of Her late Majesty Queen Victoria, chapter thirty-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, have prepared and now humbly lay before Your Majesty in Council the following scheme for

constituting a separate district for spiritual purposes to be taken out of the parish (sometime district under the Parish of Manchester Division Act 1850) of Saint James, Gorton, within the original limits of the parish of Manchester, in the county of Lancaster and in the diocese of Manchester.

"Whereas we are satisfied that the said parish of Saint James, Gorton, is a parish wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, and it has been made to appear to us that it would promote the interests of religion that the particular part of the said parish of Saint James, Gorton, which is hereinafter mentioned and described should be constituted a separate district in the manner which is hereinafter set forth.

"And whereas there is not at present within the limits of the said proposed district any consecrated church or chapel in use for the purposes of Divine worship. "And whereas we are satisfied that an

adequate and permanent maintenance for the support of the minister of the said proposed district and when the said district shall have become a new parish then for the support of the Incumbent thereof will be secured as from the date of the licensing or appointment of such minister or Incumbent by the payment of a sum of not less than one hundred and fifty pounds which will be annually provided out of the moneys received by us the said Ecclesiastical Commissioners under the provisions of the said Parish of Manchester Division Act, 1850.

" Now therefore with the consent of the Right Reverend Edmund Arbuthnott, Bishop of the said diocese of Manchester (in testimony whereof he has signed and scaled this scheme) we the said Ecclesiastical Commissioners humbly recom-mend and propose that all that part of the said parish of Saint James, Gorton, which is more particularly described in the schedule hereunder written and is delineated and set forth on the map or plan hereunto annexed, shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Saint Philip, Gorton.'

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.
