holding office in any branch of the Public' Service common to the Transvaal and Orange River Colony in regard to which the Council may for the time being have power to advise the High Commissioner.

"The Members to be nominated as above provided by the Lieutenant-Governors or by a Secretary of State or by the High Commissioner and Governor shall hold office for twelve months from the date of such nomination, and the members to be elected as above provided shall hold office for twelve months from the date of such election.

"In the event of any vacancy among the elected members a fresh election shall as soon as possible be held to fill such vacancy and the member therefor elected shall hold office until the expiration of twelve months from the date of the election of the member in whose place he has been elected.

" If any Member of the Council other than the High Commissioner and Governor or an elected member be absent from the Colony or be temporarily incapable, owing to illness or any other cause, of acting as a Member of the Council the authority by whom such member was nominated (or in the case of a member nominated by a Secretary of State or of any other member of the Council the High Commissioner and Governor) may appoint some other person to act in place of such member during such absence or temporary

incapacity. "XIV.-(1.) The Council shall every year at its ordinary meeting appoint from among its members a standing committee to be called the 'Railway Committee' consisting of not less than three or more than nine members of which Committee the Commissioner of Railways shall be Chairman.

II. His Majesty may at any time add to or amend the provisions of this Order.

III. This Order shall come into operation on publication in the London Gazette and shall be published in the High Commissioner's Gazette and in the Official Gazettes of the two Colonies.

IV. Judicial notice shall be taken of this Order and of the commencement thereof.

V. This Order may be cited as the Inter-Colonial Council South Africa Order in Council 1904.
