We humbly pray that Your Majesties may long be spared to rule over Your loyal subjects and that the Almighty in His infinite wisdom may grant Your Majesties many years of health and happiness.

To which Address His Majesty was pleased to return the following gracious Answer:—

"I thank you on behalf of the Queen and Myself for the loyal Address of welcome which you have presented to Us, and for the good wishes which you express. I still retain a pleasurable recollection of My earlier visit to Holyhead, to which you refer, and if on some future occasion the time at Our disposal were to allow Us to pay a more extended visit than is possible under the arrangements for Our present visit to Ireland, We should be greatly pleased."

Regulations dated the 29th of April, 1904, made by the Secretary of State for the Home Department for carrying into effect the provisions of the Naturalization Acts.

In exercise of the powers vested in me by the Naturalization Acts, 1870 to 1895, and with the consent of the Lords Commissioners of His Majesty's Treasury, I hereby make the following Regulations:—

- 1. No Fee shall be taken for granting a Certificate of Naturalization and for registering the same together with the oath of allegiance in the case of an Alien residing in the United Kingdom and serving on British Ships.
- 2. These Regulations shall take effect as from the 30th of April, 1904; and so much of the Regulation of the 1st February, 1872, as relates to Fees shall be deemed to be modified accordingly.
- 3. The Regulations dated the 20th October, 1897, and the 4th August, 1903, are hereby annulled.

FACTORY AND WORKSHOP ACT, 1901.

In pursuance of section 1 of the Rules Publication Act, 1893, notice is hereby given that the Secretary of State for the Home Department proposes, at the expiration of 40 days from the publication of this notice, to make an Order under section 40 (4) of the Factory and Workshop Act, 1901, extending the exceptions in that section which permit young persons to have the meal hours at different times, and to remain during meal hours in rooms in which a manufacturing process is being carried on, to male young persons employed in iron and steel foundries in the United Kingdom, and repealing the Order of the 14th July, 1903, which related to iron and steel foundries in Scotland.
