III. The Examination will be in the following subjects:—

1. English Composition.
2. Mathematics: (a) Arithmetic, Algebra, Plane and Solid Geometry, Trigonometry; (b) Differential and Integral Calculus.
3. Applied Mechanics.
4. Electricity and Magnetism.
5. Electrical Engineering and Electrical Instruments.
6. *Either* Steam, and Stationary Steam Engines, or Civil Engineering (including designs of Structures).
7. French, or German, or Italian (Translation and Composition).

* * *Subjects numbered 5 and 6 will include Drawing.*

No Candidate will be eligible who does not pass, to the satisfaction of the Civil Service Commissioners, in each of the subjects numbered 1, 2 (a), 3, 4, 5, and 6.

IV. A fee of £3 will be required from each Candidate attending the Examination.

V. Applications for permission to attend an Examination must be made at such times and in such manner as the Civil Service Commissioners may appoint.
