HEREAS the Ecclesiastical Commissioners VV for England have, in pursuance of the Act of the fifty-ninth year of His late Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, duly prepared and laid before His Majesty in Council a representation, bearing date the thirtieth day of June, in the year one thousand nine hundred and four, in the words following, that is to say:

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyniuth year of His late Majesty King George the Third chapter one hundred and thirtyfour, of the Act of the second and third years of Her late Majesty Queen Victoria, chapter forty-niue, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Gwladys, situate at Bargoed, in the parish of Gellygaer, in the county of Glamorgan and in the diocese of Llandaff.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Gwladys, situate at Bargoed as aforesaid.

"Now therefore with the consent of the Right Reverend Richard, Bishop of the said diocese of Llandaff (testified by his having signed and sealed this representation), we, the said Ecclesi-astical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Gellygaer, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Gwladys, situate at Bargoed as aforesaid and that the same should be named 'The District Chapelry of Saint Gwladys, Bargoed.'

"And with the like consent of the said Richard Bishop of the said diocese of Llandaff (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said church of Saint Gwladys, situate at Bargoed as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concurin or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Gwladys, Bargoed, being :-

"All that part of the parish of Gellygaer in the county of Glamorgan and in the diocese of Llandaff which is bounded upon the east partly by the parish of Bedwellty and partly by the consolidated chapelry of Saint Dingat
New Tredegar both in the county of Monmouth and in the said diocese of Llandaff
upon the north by the new parish of Saint
Two long Portlation and the saint s Tyfaelog Pontlottyn upon the west by the consolidated chapelry of Saint Matthias Treharris both in the said county of Glamorgan and in the said diocese of Llandaff and upon the remaining side that is to say upon the south by an imaginary line commencing at the point in the middle of the road leading from Pentwyn across Gellygaer Common to the house called Penheol-Adam where the boundary which divides the said consolidated chapelry of Saint Matthias Treharris from the said parish of Gellygaer diverges from such road and follows the course of the Llan caiach Brook and extending thence south-eastward along the middle of the said road for a distance of seven chains and a half or thereabouts to its junction with the road leading past the house called Heol-ddu uchaf to Bargoed and extending thence north-eastward along the middle of the last-mentioned road for a distance of sixty-three chains or thereabouts to the point where such road is joined by the road leading from Wingfield Pit and extending thence south-eastward and in a straight line for a distance of sixty-five chains or thereabouts to the point where the road leading from the house called Mountain Ash joins the road leading from. the house called Cwrt-y-betty past the houses called Gilfach-Fargoed-fach and Gilfach-Fargoedfawr to Bargoed and extending thence north-eastward along the middle of the last-mentioned road for a distance of sixty-one chains or thereabouts to its junction with the main road leading from Gilfach to Bargoed and extending thence due eastward and in a straight line for a distance of sixteen chains or thereabouts to a point in the middle of the Rhymney River upon the boundary which divides the said parish of Gellygaer from the said parish of Bedwellty.

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this. Order be forthwith registered by the Registrar of the said diocese of Llandaff.
