The Lords Commissioners of His Majesty's Treasury hereby give notice, that at a Trial of the Pyx, begun at Goldsmiths' Hall, in the City of London, on the 7th June, and concluded on the 6th July, 1904, in accordance with the provisions of the Orders in Council of the 29th June, 1871, and the 30th January, 1901, the following Verdicts of the Pyx Jury were delivered to the King's Remembrancer, viz:—

TRIAL OF THE PYX OF THE LONDON MINT.

VERDICT.

WE, whose names are hereunder written, having been sworn on the seventh day of June, one thousand nine hundred and four, before the King's Remembrancer, at Goldsmiths' Hall, in the City of London, have made the Assays and Trials of His Majesty's Gold and Silver Coins in the Pyx of the Royal Mint, in London, which, according to accounts produced by the Officers
