

the Administrative County of Derby, I hereby make the following Order :—

*Title.*

I. This Order may be cited as the Wild Birds Protection (County of Derby) Order, 1904.

**BIRDS.**

*Close Time extended.*

II. The time during which the killing or taking of Wild Birds is prohibited by the Act of 1880 shall be extended, so far as concerns the area comprised within the boundaries of the Administrative County of Derby, so as to be between the last day of February and the 13th day of August in any year.

*Additions to the Schedule of the Act of 1880.*

III. The Wild Birds Protection Act, 1880, shall apply throughout the area comprised within the boundaries of the Administrative County of Derby to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act :—

Corn Bunting, Reed Bunting, Common Buzzard, Honey Buzzard, Chiffchaff, Tree Creeper, Pied Flycatcher, Spotted Flycatcher, Hedge Sparrow, Heron, Kestrel, House Martin, Sand Martin, Merlin, Osprey, Meadow Pipit, Shrike (Butcher Bird), Swallow, Swift, Missel Thrush, Song Thrush, Bearded Tit, Grey Wagtail, Blue-headed Wagtail, Pied Wagtail, White Wagtail, Yellow Wagtail, Blackcap Warbler, Garden Warbler, Grasshopper Warbler, Reed Warbler, Wheatear, Whinchat, Whitethroat, Lesser White-throat, Golden-crested Wren, Wood Wren, Wry-neck.

*Certain Birds protected during the whole of the Year.*

IV. During the period between the 12th day of August in any year and the 1st day of March following, the taking or killing of the following species of Wild Birds is prohibited throughout the area comprised within the boundaries of the Administrative County of Derby :—

Bittern, Great Crested Grebe, Kingfisher, Brown Owl, Long-eared Owl, Short-eared Owl, White Owl, Green Woodpecker, Great Spotted Woodpecker, Lesser Spotted Woodpecker.

*Certain Birds protected on Sundays throughout the County.*

V. During the period between the 12th day of August in any year and the 1st day of March following, it shall be unlawful throughout the area comprised within the boundaries of the Administrative County of Derby to kill or take on Sunday (a) any of the Birds mentioned in Clause VI of this Order, (b) any of the Birds mentioned in the Schedule to the Wild Birds Protection Act, 1880, as amended by the Act of 1881, and (c) any of the Birds added to the said Schedule by Clause III of this Order.

**EGGS.**

*Certain Eggs protected throughout the County.*

VI. The taking or destroying of the Eggs of the following species of Wild Birds and of the Eggs of the Birds mentioned in the Schedule to the Wild Birds Protection Act, 1880, as amended by the Act of 1881, or added thereto by Clause III of this Order, is prohibited throughout the

area comprised within the boundaries of the Administrative County of Derby :—

Gull Bunting, Bullfinch, Yellow Bunting (Yellow Hammer), Turtle Dove, Tufted Duck, Gadwall, Hawfinch, Brown Linnet, Nuthatch, Ring Ouzel, Pintail, Tree Pipit, Redstart, Robin, Coal Tit, Marsh Tit, Long-tailed Tit, Sedge Warbler, Woodlark, Willow Wren.

*Repeal of former Order.*

VII. The Order of the 21st January, 1899, is hereby repealed.

**SHORES OR BANKS OF THE SEA AT SWALECLIFFE, HERNE BAY.**

The Board of Trade hereby revoke the Order made by them on the 21st day of January, 1904, prohibiting the removal of shingle or ballast from the shores or banks of the sea at Swalecliffe between a point opposite the Brook discharging at Swalecliffe Point and the eastern boundary of the Whitstable Urban District, which boundary is in the said Order described as being situated 330 yards east of Priest and Sow Corner at the seaward end of Herne Bay-road, Whitstable.
