#### THE FAIRS ACT, 1871. SLOE FAIR, CHICHESTER.

The Secretary of State for the Home Department hereby gives notice that by Memorial, dated 22nd July, 1904, a representation has been duly made to him by the City Council of Chichester, that a Fair has been annually held at Chichester on October 20th, and that it would be for the convenience and advantage of the public that such Fair should be abolished.
