

the Reverend John Francis Tarleton, Clerk in Holy Orders, as the Rector or Incumbent of the said rectory, have by an Instrument bearing date on or about the first day of June, in the year one thousand nine hundred and four, and being under the hands of the said Edgar, Bishop of Saint Albans, and the said John Francis Tarleton, and under the common seal of the said College, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said parish of Great Warley, that the said new church of Saint Mary the Virgin, situate within such parish, should be substituted for the old parish church (also dedicated to Saint Mary) of the same parish.

Now, therefore, we the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do by this Instrument, under our common seal, with the consents (testified as hereinafter mentioned) of the said Edgar, Bishop of the said diocese of Saint Albans, and of the said Master, Fellows, and Scholars of the College of Saint John the Evangelist in the University of Cambridge, and of the said John Francis Tarleton, hereby declare that the said new church of Saint Mary the Virgin, situate within the said parish of Great Warley, and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church (dedicated to Saint Mary as aforesaid) of the same parish, and that such new church shall henceforth be the parish church of the said parish of Great Warley, in lieu of the said old parish church of Saint Mary, as fully in all respects as if the said new church of Saint Mary the Virgin, so hereby substituted, had been originally the parish church of the same parish; and we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church (dedicated to Saint Mary as aforesaid) of the said parish of Great Warley, or of or belonging to the Rector or Incumbent thereof, to the said new church of Saint Mary the Virgin (now being by virtue of these presents the parish church of the said parish of Great Warley) and to the Rector or Incumbent thereof, and his successors, for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said Edgar, Bishop of the said diocese of Saint Albans, has set his hand and affixed his episcopal seal, and the said Master, Fellows, and Scholars of the College of Saint John the Evangelist in the University of Cambridge, have set their common seal, and the said John Francis Tarleton has set his hand and affixed his seal this fourteenth day of July, in the year one thousand nine hundred and four.

## No. 669.—UNITED STATES, ATLANTIC COAST—MASSACHUSETTS, NANTUCKET SOUND APPROACH.

*Pollock Rip—Beacon Destroyed.*

The United States Government has given notice, dated 16th July, 1904, that the skeleton beacon, surmounted by a ball, on the southern part of Pollock Rip Shoals, situated at a distance of 3 miles S. 60° E. from Monomoy Point Lighthouse, has been destroyed.

Approximate position, lat. 41° 32½' N., long. 69° 55½' W.

## No. 670.—ENGLAND—SOUTH COAST.

*Dover Harbour Works—Gas Lighted Bell Buoy Moved.*

With reference to Notice to Mariners No. 287 of 1903:—

Information has been received from the Trinity House, London, dated July 22nd, 1904, that the gas-lighted bell buoy, conical in shape, painted green, and marked "Dover Pier Works," from which a white group flashing light, showing groups of two flashes every ten seconds, is exhibited, has been moved one cable S. 34° W. from the position which it formerly occupied near the prolongation of the eastern breakwater of Dover Harbour; it is now moored in a depth of 7½ fathoms with the temporary Pier light bearing N. 41° W., distant 7½ cables, and Admiralty Pier turret S. 85° W.

Approximate position, lat. 51° 7' N., long. 1° 20½' E.

CAUTION.—Vessels should on no account pass inshore or to the northward of this buoy.
