The KING has been pleased to appoint Walter Egerton Esq., C.M.G., High Commissioner for the Protectorate of Southern Nigeria, to be also Governor and Commander-in-Chief of the Colony of Lagos.

The KING has been pleased to give and grant unto Walter William Adrian MacGeough Bond, Esq., Vice-President of the Egyptian Native Court of Appeal, His Majesty's Royal licence and authority that he may accept and wear the Insignia of the Second Class of the Imperial Ottoman Order of the Medjidieh, and the Insignia of the Third Class of the Imperial Ottoman Order of the Osmanieh, which Decorations have been conferred upon him by His Highness the Khedive of Egypt, authorized by His Imperial Majesty the Sultan of Turkey, in recognition of valuable services rendered by him to His Highness.

The KING has been pleased to grant unto Calvert Healy, of Royal Farm, in the parish of Peperharrow, in the county of Surrey, Gentleman, third son of Colonel Richard Calvert Healy, and a Lieutenant in the 2nd Battalion of His Majesty's Oxfordshire Light Infantry, His Royal licence and authority that he may in compliance with a clause contained in the last will and testament of his maternal uncle, Algernon Charles Fitzgerald, formerly of Lincoln's Inn Fields, in the county of Middlesex, but late of Royal Farm

aforsaid, Gentleman, deceased, take and henceforth use the surname of Fitzgerald in lieu of that of Healy, that he may bear the arms of Fitzgerald, and that such surname and arms may in like manner be taken, borne, and used by his issue; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And also to command that the said Royal concession and declaration be recorded in His Majesty's said College of Arms.
