

### TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Thursday, the 29th instant, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vic., cap. 2, 52 Vic., cap. 6, and 4 Edw. VII, c. 17, to the amount of £3,000,000, in replacement of Bills falling due on the 5th proximo.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000 and will be dated the 5th October, 1904. Bills for £1,000,000 will be payable at three months after date, viz.:—on the 5th January, 1905, and Bills for £2,000,000 at twelve months after date, viz.:—on the 5th October, 1905.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for, and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Friday, the 30th instant, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock, on Wednesday, the 5th October, 1904.

6. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

### REGISTRATION OF BIRTHS AND DEATHS.

Notice is hereby given, that in pursuance of the provisions of the twenty-first section of an Act passed in the thirty-eighth year of the reign of Her late Majesty, intituled "The Births and Deaths Registration Act, 1874," I, Sir William Cospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, have, with the sanction of the Local Government Board, ordered and declared that, on and after the first day of October next, in order that Kettering Registration District may consist of three Sub-Districts, each co-extensive with one of the three Relief Districts of Kettering Poor Law Union as now constituted, Kettering Sub-District shall be divided into two Sub-Districts, constituted as follows, viz.:—(a) A Sub-District to be called and known as Kettering Sub-District, and to consist of Kettering Civil Parish and Urban District; and (b) A Sub-District to be called and known as Burton Latimer Sub-District and to consist of Barton Seagrave, Broughton, Burton Latimer, Cranford St. Andrew, Cranford St. John, Cransley, Geddington, Grafton Underwood, Newton, Pytchley, Warkton, and Weekley Civil Parishes.—Witness my hand this 22nd day of September, one thousand nine hundred and four.
