Vaughan Lewes, D.S.O., His Majesty's ship "Fearless, that Warren Island light is a white group flashing light, showing groups of four flashes every forty-two seconds, each flash and eclipse in the group occupying about seven seconds, and the groups being separated by an eclipse of fourteen seconds; it is shown from a building about 28 feet high at an elevation of 120 feet above high water, and should be visible in clear weather all round the horizon from a distance of 15 miles.
