A PROCLAMATION.

EDWARD, R. & I.

Whereas Our Parliament stands prorogued to Thursday, the third day of November, one thousand nine hundred and four; We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare that the said Parliament be further prorogued to Tuesday, the twentieth day of December, one thousand nine hundred and four.

Given at Our Court at *Buckingham Palace*, this twenty-fourth day of *October*, in the year of our Lord one thousand nine hundred and four, and in the fourth year of Our Reign.
