

In Parliament.—Session 1905.

BUDLEIGH SALTERTON URBAN DISTRICT WATER.

(Construction of Waterworks; Power to take and divert, &c., Water; Compulsory Acquisition of Lands; Exemption from Section 92 of Lands Clauses Consolidation Act, 1845, and with respect to superfluous Lands; Common Lands; Interference with Highways, Streams and other Property; Compensation for taking Water; Agreements with Landowners and Millowners as to Water Rights, Drainage and Preservation of Purity of Water; Protection of Drainage Area from Pollution; Making of Bye-laws for Preventing Waste, &c., of Water; Levying Rates and Charges; Supply of Water in bulk to Authorities, Bodies and Persons; Borrowing of Money; Exclusion of Water Loans from operation of Public Health Act, 1875; Incorporation, Repeal and Amendment of Acts.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session by the Urban District Council of Budleigh Salterton (hereinafter called "the Council") for leave to bring in a Bill for an Act for all or some of the following purposes (that is to say):—

1. To empower the Council to make and maintain the following waterworks or other works or some of them, or some part or parts thereof, all in the county of Devon (that is to say):—

Work No. 1.—A storage reservoir, to be called "the Colaton Raleigh Reservoir," situate in the parishes of Colaton Raleigh and Bicton, on commonable lands numbered 437 in the parish of Colaton Raleigh and 1 in the parish of Bicton on the $\frac{25}{100}$ Ordnance Map, Devonshire sheet xciii-3 (1890 edition) and sheet xciii-7 (1889 edition), to be formed by means of a dam or embankment 250 yards, or thereabouts, in length from south-west to north-east across the valley of the tributary stream known as the Stowford Brook which feeds the Bicton leat and the Colaton Raleigh Brook, at a point on the said Stowford Brook 323 yards, or thereabouts, measured in an easterly direction from the point of junction of the boundaries of the parishes of Colaton Raleigh, Bicton and Woodbury, and which reservoir will extend from the said dam or embankment to a point on the Stowford Brook 190 yards, or thereabouts, measured in a straight line in a north-westerly direction. The said embankment will extend from the centre of the Stowford Brook in a south-westerly direction for a distance of 175 yards, or thereabouts, and in a north-easterly direction for a distance of 75 yards, or thereabouts.

Work No. 2.—An aqueduct, conduit, or line or lines of pipes, wholly situate in the parish of Colaton Raleigh, commencing at or in the intended storage reservoir (Work No. 1) at a point 300 yards, or thereabouts, measured in an easterly direction from the point of junction of the boundaries of the parishes of Colaton Raleigh, Bicton and Woodbury, and terminating at or near the filter beds of the service reservoir (Work No. 3) hereinafter described.

Work No. 3.—A service reservoir with filter beds, wholly situate in the parish of Colaton Raleigh on commonable land, numbered 437 on the $\frac{25}{100}$ Ordnance Map, Devonshire sheet xciii-3 (1890 edition), on the northern side of the Stowford Brook, and 27 yards, or

thereabouts, measured in a south-easterly direction from the dam or embankment of the storage reservoir (Work No. 1) hereinbefore described.

Work No. 4.—An aqueduct, conduit, or line of pipes, commencing at or in the intended service reservoir (Work No. 3) in the parish of Colaton Raleigh, passing from thence into and through the parishes of Bicton and East Budleigh, and terminating in the parish and urban district of Budleigh Salterton at a point in West Hill 100 yards, or thereabouts, measured in an easterly direction from its junction with Halse Hill.

Work No. 5.—A compensation reservoir, situate wholly in the parish of Colaton Raleigh, on commonable land numbered 437 on the $\frac{25}{100}$ Ordnance Map, Devonshire sheet xciii-3 (1890 edition) and sheet xciii-7 (1889 edition), to be formed by means of a dam or embankment 87 yards, or thereabouts, in length from north to south, across the valley of the Stowford Brook and the West Kettle Brook at or near the point where the West Kettle Brook joins the Bicton leat at a point on the said leat 200 yards, or thereabouts, measured in a westerly direction from the south-west corner of the Kettle Plantation, and which reservoir will extend from the said dam or embankment 17 yards, or thereabouts, measured in a straight line in a westerly direction. The said dam or embankment will extend from the centre of the Bicton leat in a northerly direction for a distance of 80 yards, or thereabouts, and in a southerly direction for a distance of 7 yards, or thereabouts.

Together with all proper dams, walls, embankments, bridges, roads, ways, wells, tanks, cisterns, basins, gauges, filters, filter beds, sluices, bye washes, waste weirs, inlet works, outfalls, discharge pipes, shafts, tunnels, adits, aqueducts, culverts, cuts, catchwaters, channels, conduits, mains, pipes, stand pipes, junctions, valves, hatch boxes, chambers, drains, telegraphs, telephones, engines, apparatus, roadways, approaches, fences, buildings, houses, works and conveniences connected with the hereinbefore described works or any of them, or incidental thereto or necessary for conducting, controlling, inspecting, cleansing, repairing or managing the same, and together with full power and right at all times of approach and access to the works aforesaid, or any of them.

2. To empower the Council to deviate from the lines and levels of the intended works as shown on the plans and sections thereof to be deposited as hereinafter mentioned, to any such extent as may be prescribed or authorized by the intended Act.

3. To incorporate with the Bill and to apply to the aforesaid works or any of them the provisions or some of the provisions of the Railways Clauses Consolidation Act, 1845, with respect to the temporary occupation of lands near the railways during the construction of the intended works.

4. To empower the Council to take, collect, divert, impound and use for the purposes of their water Undertaking, and for all or any other purposes of the intended Act, all such brooks, streams, springs, leats and waters as can or may be intercepted or taken by the intended works, or as may be found on, in or under any of the lands for the time being belonging to, or which may be acquired by, the Council, or over or in respect of which they have or may acquire easements, and especially the waters of the
