NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session by the Mayor, Aldermen and Burgesses of the County Borough of Bolton, in the County of Lancaster (hereinafter called "the Corporation"), acting by their Council as the Urban Sanitary and Local Education Authority for the said Borough, for leave to introduce a Bill for the following or some of the following purposes (that is to say) :—

Waterworks.

To enable the Corporation to make and maintain the reservoirs and waterworks in the county of Lancaster, hereinafter described, together with all necessary and proper works and conveniences

connected therewith or ancillary thereto, or required for collecting and impounding the waters which by the intended Act the Corporation will be empowered to take (that is to say):—

Work A (Hordern reservoir).—A reservoir situate wholly in the parish or township of Belmont, in the urban district of Turton, to be formed by the construction of a dam or embankment across the Hordern Brook at a point 36 chains, or thereabouts, westward from the Ordnance Bench mark at the north-easterly end of St. Peter's Church, Belmont, and to extend westwards from the said embankment up the said Hordern Brook for a distance measured along that brook of 29 chains or thereabouts.

The said dam or embankment will commence at a point 10 chains, or thereabouts, north and terminate at a point $3\frac{1}{2}$ chains, or thereabouts, south of the point (hereinbefore described) where the same crosses the said Hordern Brook.

Work B.—A catchwater or conduit in the said parish of Belmont, commencing in the stream known as the Great Gutter at a point in such stream 4 chains south of the footbridge over such stream on the south side of the Wards reservoir and terminating in the intended Hordern reservoir near the southern end of the intended dam or embankment.

Work C.—A new road, wholly in the said parish of Belmont, commencing by a junction with the Rivington-road at a point 11 chains, or thereabouts. eastward from Hordern Stoops and terminating by a junction with the Highstreet, Belmont, on the southern side of the Black Bull public-house, and in connection therewith to empower the Corporation to stop up so much of Rivington-road as lies between the point of commencement of the proposed new road and a point 5 chains east of the foot of the outer slope of the embankment of the proposed Hordern reservoir.

Work D.—An aqueduct, tunnel, conduit or line of pipes, wholly in the said parish of Belmont, commencing in the said intended Hordern reservoir and terminating in the line or lines of pipes, Work E, hereinafter described, at the junction of Church-street with High-street, Belmont.

Work E.--An aqueduct, conduit or line or lines of pipes, commencing in the said parish of Belmont at the gauge basin on the southern face of the existing embankment of the Belmont reservoir, and terminating in the parish and borough of Bolton at the existing reservoir known as the Sweetloves service reservoir.

Work F (Eagley reservoir).—A reservoir, partly in the said parish of Belmont and partly in the parish or township of Turton, in the said urban district of Turton, to be formed by a dam or embankment across the Belmont or Eagley Brook at a point 5 chains, or thereabouts, northwest of the Longworth Mill, and to extend up the said brook for a distance measured along the said brook of $88\frac{1}{2}$ chains, or thereabouts, from the same point.

The said dam or embankment will commence at a point in the said parish of Belmont on the western side of the said brook 7 chains, or thereabouts, westward from the point (hereinbefore described) where the same is intended to cross the said brook, and will terminate at a point in the said parish of Turton 9 chains, or
