**RULES PUBLICATION ACT, 1893.**

Rule of the Court of the Railway and Canal Commission.

The following draft Rule is published pursuant to the above-mentioned Act:—

No application under section 3 of the Railways (Private Sidings) Act, 1904, shall be filed without the consent of the Commissioners, and such consent shall be signified by sealing the endorsement on such application.

The applicant shall leave at the Commissioners' Office a copy of the application proposed to be filed and served, and shall also leave an affidavit verifying the statements in such application.
