The Wild Birds Protection (County of Denbigh) Order, 1904.

Dated 20th December, 1904.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1904, and upon application by the County Council of the Administrative County of Denbigh, I hereby make the following Order:-

Title.

I. This Order may be cited as "The Wild Birds Protection (County of Denbigh) Order, 1904.

BIRDS.

Partial Extension of Close Time.

II. The time during which the killing or taking of the following species of Wild Birds is prohibited by the Wild Birds Protection Act, 1880, shall be extended throughout the county of Denbigh so as to be between the last day of February and the 1st day of October in any year :-

American Quail, Auk, Avocet, Bee Eater, Bittern, Bonxie, Colin, Cornish Chough, Coulterneb, Cuckoo, Dotterel, Dunlin, Fulmar, Gannet, Godwit, Grebe, Greenshank, Guillemot, Gull (except black-backed Gull), Hoopoe, Kittiwake, Loon, Marrot, Merganser, Murre, Nightingale, Nightjar (Fern Owl, Goatsucker, or Night Hawk), Oriole Orbird Overton Catalogue, Petrol Phalance, Oriole, Oxbird, Oyster Catcher, Petrel, Phalarope, Ploverspage, Puffin, Purre, Razorbill, Redshank, Reeve or Ruff, Roller, Sanderling, Sandpiper, Scout, Sealark, Seamew, Sea Parrot, Sea Swallow, Shearwater, Sheldrake, Skua, Smew, Solan Goose, Spoonbill, Stint, Stone Curlew (Thick Knee), Stonehatch, Summersnipe, Tarrock, Tern, Tystey, Whaup, Whimbrel, Willock, Woodpecker.

Additions to the Schedule of the Act of 1880.

III. The Wild Birds Protection Act, 1880, shall apply within the County of Denbigh to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:

Yellow Bunting, Peregrine Falcon, Pied Flycatcher, Hedge Sparrow, Raven, Redstart, Robin Redbreast, Red-backed Shrike, Starling, Thrush, Treecreener. Wagtail, Blackcap Warbler, Wheatear, Common Wren, Golden-crested Wren.

Certain Birds protected during the whole of the

species of Wild Birds is prohibited throughout the county of Denbigh :-

Common Buzzard, Goldfinch, Heron, Kingfisher, Lark, Linnet (brown and green), Owl, Siskin.

FACTORY AND WORKSHOP ACT, 1901.

The Secretary of State for the Home Department hereby gives notice, pursuant to section 80 of the Factory and Workshop Act, 1901, that he has certified to be dangerous certain machinery used in the process of spinning in textile factories and known as self-acting mules, and that he proposes to make Regulations to apply to all factories or parts thereof in which the process of spinning by means of self-acting mules is carried on.
