NOTICES TO MARINERS.

(Nos. 1223 to 1239 of the year 1904.)

[The bearings are magnetic, and those concerning the visibility of lights are given from seaward.]

No. 1223—PERSIAN GULF.

*Abu Shahr (Bushire)—Beacon and Buoys  
Established.*

Information, dated 25th November, 1904, has been received from Captain T. W. Heming, in charge of the Marine Survey of India, that the undermentioned beacon and buoys have been established at Abu Shahr (Bushire):—

1. A red iron pile beacon surmounted by a cask with a red band has been erected at the south end of Ras al Murg in a position from which the Residency flagstaff bears S. 29° E., distant 23½ cables, and the Bar Abbásak single tree N. 83° E.
2. A black spar buoy surmounted by a diamond has been moored in a position from which the Residency flagstaff bears N. 62° E., distant 2½ miles, and the German Consulate flagstaff S. 61° E.
3. A red spar buoy surmounted by a diamond has been moored in a position with the Residency flagstaff bearing N. 65° E., distant 1¼ miles, and the German Consulate flagstaff S. 35° E.
4. A black spar buoy surmounted by a triangle has been moored in a position from which the Residency flagstaff bears S. 80° E., distant 2¼ miles, and the German Consulate flagstaff S. 31° E.
5. A black spar buoy surmounted by a triangle has been moored in position from which the Residency flagstaff bears S. 53° E., distant 25½ cables, and Bar Abbásak single tree N. 77° E.
6. A red spar buoy surmounted by a triangle has been moored in a position from which the Residency flagstaff bears S. 49° E., distant 2¼ miles, and Bar Abbásak single tree N. 74° E.
7. A white spar buoy surmounted by a black triangle has been moored in a position from which the Residency flagstaff bears S. 31° E., distant 2¼ miles, and Bar Abbásak single tree East.

Also, that the tower on the south side of the entrance to Khor Bandarga apparently no longer exists, as it could not be identified.

Approximate position, Residency flagstaff, lat. 28° 59' N., long. 50° 49½' E.
