Theophila Gotto, wife of the Reverend Donald Gotto, of Shenley Rectory, in the said county of Hertford, Clerk in Holy Orders, as the patrons of the rectory of the said parish of Shenley, and with the consent of Elizabeth, Countess of Caledon, as the patron of the vicarage of the said parish of Ridge, and with the consent of the Right Honourable Hardinge Stanley, Earl of Halsbury, Lord High Chancellor of Great Britain, acting on behalf of Your Majesty as the patron of the rectory of the said parish of Elstree (in testimony whereof they, the said consenting parties, have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parish of Chipping Barnet, of the said parish of Shenley, of the said parish of Ridge, of the said parish of Elstree, and of the said particular district of Saint Paul, Mill Hill, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Peter, situate at Arkley aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Peter, Arkley, and that such consolidated chapelry should become and be and form part of the said diocese of Saint Albans, and should be included within and form part of the rural deanery of Barnet and of the archdeaconry of Saint Albans, within such last-named diocese.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Peter,

of Chipping Barnet, of the parish of Shenley, of the parish of Ridge, and of the parish of Elstree, all in the county of Hertford and in the discuss of Shenley, the diocese of Saint Albans, and of the particular district of Saint Paul, Mill Hill, in the county of Middlesex, and in the diocese of London, which are comprised within and are bounded by an imaginary line commencing at the point in Galley-lane, near its junction with the road which leads from Arkley-lane past the south-eastern sides of the houses called Oak Lodge, otherwise The Oaks, and Three Elms Farm to Chipping Barnet, where the boundaries of the said parish of Ridge, the parish of South Mimms in the said county of Hertford and in the said diocese of Saint Albans, and the said parish of Chipping Barnet all meet, and extending thence north-eastward along the boundary which divides the said parish of South Mimms from the said parish of Chipping Barnet for a distance of eight chains or thereabouts to the point where such boundary is intersected by the boundary of the urban district of Barnet, and extending thence first southward then southeastward and then south-westward along the said urban district boundary for a distance of twenty chains or thereabouts to the point at the eastern corner of the close numbered 109 upon the ordnance map of the parish of Chipping Barnet, published in the year one thousand eight hundred and ninety-eight upon the scale of twenty-five inches to the mile, and also upon the

south-eastward across Wellhouse-lane, and extending thence first generally south-westward then generally south-eastward or southward, and then again generally south-westward and south-ward along the fences which divide Wellhouselane and the closes numbered 92, 94, 95, 82 and 81 upon the said maps, the lane which forms the south-western continuation of the road called Bell's Hill and the close numbered 75 upon the said maps from the said close numbered 109 and the closes numbered 108, 106, 105, 104, 102, 101, 96, 80, 78, 77, 76 and 138 upon the said maps for a distance of one mile and seventeen chains or thereabouts, to the point at the southern end of the fence which divides the said close numbered 75 from the said close numbered 138 upon the northern side of May's-lane, and extending thence south-westward diagonally across May's-lane for a distance of forty yards or thereabouts to the point where such lane is joined by the footpath leading to Highwood Hill, and extending thence south-westward along the middle of the said footpath for a distance of nine chains and a half or thereabouts to the centre of the bridge which carries such footpath across Dollis Brook, upon the boundary which divides the said parish of Chipping Barnet from the parish of Totteridge, in the said county of Hertford and in the said diocese of Saint Albans, and extending thence westward along such boundary and along the boundary which divides the said parish of Chipping Barnet from the said particular district of Saint Paul, Mill Hill, for a distance of thirty-one chains or thereabouts to the point where such last-mentioned boundary meets Hendon Woodlane, and extending thence first south-westward to and then north-westward along the middle of Hendon Wood-lane for a distance of three chains or thereabouts, to a point opposite to the fence which divides the close numbered forty-one upon the ordnance map of the said parish of Hendon published in the year one thousand eight hundred and ninety-eight, upon the scale of twenty-five inches to a mile, and also upon the said map or plan which is annexed to this scheme, from the close numbered 17 upon the said maps and extending thence first south-westward to the said fence and then first south-westward, then northwestward, then again south-westward and then westward along the fences which divide the said close numbered 41 and the closes numbered 40, 51, 52, 54, 55, 56, 58, 59, 60, 65, 64 and 85 upon the said maps from the said close numbered 17 and the closes numbered 39, 38, 37, 61, 63 and 62 upon the said maps for a distance of one mile and thirty-four chains or thereabouts, to the point where the fence which divides the said close numbered 85 from the said close numbered 62 meets the left bank of the stream which here forms the boundary between the said particular district of Saint Paul, Mill Hill, and the parish of Edgware, in the said county of Middlesex and in the said diocese of London, and extending thence first westward to and then northward along the last-mentioned boundary for a distance of sixtyone chains or thereabouts to the point where it meets the boundary which divides the said parish of Edgware from the said parish of Elstree, and extending thence north-westward along the lastmentioned boundary for a distance of twentythree chains or thereabouts, to the point where such boundary meets the south-western side of the road leading from Elstree to Chipping Barnet, and extending theuce first north-eastward to and then south-eastward along the middle of such road for a distance of eleven chains or thereabouts to its junction with Furzehill-road, and extending map or plan which is annexed to this scheme thence north-westward along the middle of where the said urban district boundary turns Furzehill-road for a distance of seventeen chains
