

the said church of Saint Mark, Mitcham, situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Edward Stuart, Bishop of the said diocese of Rochester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of Mitcham, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Mark, Mitcham, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Mark, Mitcham.' And with the like consent of the said Edward Stuart, Bishop of the said diocese of Rochester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Mark, Mitcham, situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being. Provided always that so long as the Reverend Daniel Frederic Wilson, Clerk in Holy Orders, the present Vicar or Incumbent of the vicarage of the said parish of Mitcham shall continue to be such Vicar or Incumbent, all the fees which may be received in respect of such publication, solemnization or performance at the said church of Saint Mark, Mitcham, situate as aforesaid, shall be paid over by the minister thereof to the said Daniel Frederic Wilson; and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Mark, Mitcham, being:—

"All that part of the parish of Mitcham, in the county of Surrey, and in the diocese of Rochester, which is bounded upon the east by the new parish of Christ Church, Broad Green, Croydon, in the said county of Surrey, and in the diocese of Canterbury, upon the north partly by the new parish of Saint Andrew, Lower Streatham, partly by the new parish of Emmanuel, Streatham, and partly by the new parish of Christ Church, Mitcham, all in the said county of Surrey, and in the diocese of Rochester, and upon the remaining side, that is to say, upon the south-west, by an imaginary line commencing upon the boundary which divides the said new parish of Christ Church, Mitcham, from the said parish of Mitcham, at a point in the middle of Western-road where such road is joined by the occupation road which leads from the London-road past the site of the Manor House and past the Holborn Union Gasworks, and extending thence south-eastward along the middle of Western-road for a

distance of thirty-six chains or thereabouts to its junction with the road running along the south-western side of Upper Green, and extending thence south-eastward along the middle of the last-mentioned road for a distance of fourteen chains or thereabouts to its junction with the road called Commonsides West and with the road called Commonsides East, and extending thence south-eastward along the middle of the road called Commonsides East for a distance of one mile and forty-five chains or thereabouts to its junction with Galpin's-road and with the roadway or footpath leading into Thornton-road, and extending thence south-eastward along the middle of the said roadway or footpath for a distance of five chains or thereabouts to the boundary which divides the said parish of Mitcham from the said new parish of Christ Church, Broad Green, Croydon."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

#### COAL MINES REGULATION ACT, 1896.

The Secretary of State for the Home Department hereby gives notice that on the 11th February, 1905, he made an Order under section 6 of the Coal Mines Regulation Act, 1896, entitled "The Explosives in Coal Mines Order of the 11th February, 1905"; the effect of which is to add four explosives, Abbeite, Minite, Monobel Powder, and Russelite, to the list of Permitted Explosives.
