

PRESENT.

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four, of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirtythird years of Her said late Majesty chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation bearing date the ninth day of March, in the year one thousand nine hundred and five, in the words and figures following, that is to say:—
"We, the Ecclesiastical Commissioners for

England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four of the Act of the three-inth and fourteenth years of Her said late Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Christ Church, Cwmamman, situate partly in the county of Carmarthen and partly in the county of Glamorgan and wholly in the diocese of Saint David's, and of the new parish of Saint Catherine, Brynamman, situate in the said county of Carmarthen and in the said diocese of Saint David's. the said diocese of Saint David's.

"Whereas by the authority of an Order of Hersaid late Majesty in Council bearing date the second day of October in the year one thousand eight hundred and forty-three and published in the London Gazette on the nineteenth day of the following December, a consolidated chapelry district was assigned to the consecrated church called Christ Church at Cwmamman in the parish

marthen, and the said consolidated chapelry district was named 'The Consolidated Chapelry

District of Christ Church, Cwmamman.'
"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the sixth day of April in the year one thousand eight hundred and eighty-nine and published in the London Gazette on the twelfth day of the same month, a district chapelry was assigned to the Church of Saint Catherine situate at Brynamman within the said cure of Christ Church, Cwmamman, and the said district chapelry was named 'The District Chapelry of

Saint Catherine, Brynamman.'
"And whereas the said consolidated chapelry district of Christ Church, Cwmamman, and the said district chapelry of Saint Catherine, Brynamman, have become new parishes of the character contemplated by the Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven by the Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four, and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter pinety-four. chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Christ Church, Cwmamman, and of the said new parish of Saint Catherine, Brynamman, should be altered in the manner which is hereinafter mentioned.

"Now therefore with the consent of the Right Reverend John Bishop of the said diocese of Saint David's (in testimony whereof he has signed and sealed this scheme or representation) we, the said Ecclesiastical Commissioners, humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the
