Notwithstanding the provisions of the Swine-Fever (Regulation of Movement) Order of 1903, or of any Order by which such provisions are applied to any scheduled area, swine may be moved to the exhibition mentioned in the Schedule hereto, and from such exhibition to any place of destination in Great Britain situate in any scheduled area, if accompanied by a Licence authorising such movement granted by an Inspector of the Local Authority of the District in which are situate the exhibition or place of destination, as the case may be, to which the swine are proposed to be moved.

The swine shall be moved by the nearest available route and without unnecessary delay to the exhibition or place of destination specified in the licence and not elsewhere, and while being so moved shall not be subject to Regulations made by a Local Authority under any Order of the Read relating to Swine Force.
