The KING has been pleased to grant unto Wilfred Arthur Duncombe, of York-street, in the parish of Saint James's, in the city of Westminster and county of London, a Lieutenant, Reserve of Officers of His Majesty's 6th Regiment of Dragoon Guards, and Margaret Louise Anderson, of Lea Hall, in the parish of Lea, in the county of Lincoln, Spinster, eldest daughter and coheir of Francis Foljambe Anderson, late of Lea aforesaid, Esquire, in the Commission of the Peace for the Parts of Lindsey, in the county of Lincoln, second but eldest surviving son and heir of Sir Charles Henry John Anderson, late of Lea Hall aforesaid, Baronet, Master of Arts of the University of Oxford, a Deputy Lieutenant and (in 1851) High Sheriff for the county of Lincoln, His Royal licence and authority that they may, in compliance with a clause contained in an Indenture of Settlement bearing date the eighth day of June, one thousand eight hundred and sixty-five, between the said Sir Charles Henry John Anderson, Baronet, of the first part, the said Francis Foljambe Anderson of the second part, and others of the third and fourth parts, immediately on and from the solemnization of their intended marriage, take and thenceforth use the surname of Anderson in addition to and after that of Duncombe, that he the said Wilfred Arthur Duncombe may bear the arms of Anderson quarterly in the first and fourth quarters with those of Duncombe, and that such surname and arms may in like manner be taken, borne, and used by the issue of the said intended marriage: the said arms being first duly exemplified according to the laws of arms and recorded in His Majesty's College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in His Majesty's College of Arms.
